Inviting suitable proposal from Farmers Clusters for the Implementation of Integrated Farming for Productivity Improvement in Farmers field Laying out of Demonstration plot (LoDP) - during 2022-23

The Technical committee meeting on Direct Implementation of Integrated Farming for Productivity Improvement in Farmers field- Laying out of Demonstration plot (LoDP) to identify thrust area in Kerala was held on 27.01.2023 in Hybrid mode under the Chairmanship of Dr. Hanumanthe Gowda, Chief Coconut Development Officer, CDB. Dr Madhu Subramanian, Director of Research, KAU, Vellanikkara, Dr.Subramanian P, Principal Scientist, CPCRI, Kasargod, Shri. Animon, Deputy Director of Agriculture (CD), Dept of Agriculture, Govt. of Kerala Shri. Pramod Kurian, Assistant Director (Dev) attended the meeting. The thrust area for the implementation of the scheme is decided to be identified in districts of Kozhikode, Malappuram and Kannur. Suitable applications are invite form Farmers Clusters of Kozhikode, Malappuram, Kannur districts and other coconut growing districts in the application form annexed. Suitable Farmers Cluster will be selected for LoDP implementation in consultation with PAO of concerned district.

Suitable applications are invited from the Farmers Clusters from ODOP coconut district of Kozhikode, Malappuram & Kannur in the application form Annexed under the CDB approved terms & conditions laid for the implementation of the above scheme. However applications from other coconut growing districts will also be considered based the merit of the proposal.

Interested Farmers Clusters may submit their applications in the prescribed formats annexed, latest by on or before 3 PM of 01.03.23. The application can be submitted either by hand or through Speed post.

- 1. Duly filled in application should be submitted in the prescribed format (Enclosed)
- 2. An endorsement letter from the Facilitating Agency should be furnished along with application if that *Coconut Farmer Cluster is sponsored by FPO, KVK,Agri.Dept., SAU etc.
- 3. The Proposed project area should be contiguous with definite Political/ administrative boundaries like wards/ villages/ blocks.
- 4. The proposed project are should have a minimum area of 25 ha and a maximum area of 200 ha. Coconut gardens.
- 5. All coconut farmers with a minimum of 10 palms of age 5 years or more within the cluster area and willing to participate/implement the scheme should be included in the cluster.
- 6. The proposed project area should not availed Financial Assistance under CDB- R&R or LoDP schemes during last five years, either from CDB or through State dept.
- 7. Individual assistance under the scheme should be limited to 1ha / farmer, irrespective of actual land holding.
- 8. Expenses on labour, other rental services, development of infrastructure, etc. are not considered under the scheme and have to be met by the farmers /cluster.
- 9. Based on the merit of the proposed area CDB shall short list the *CFCs for the implementation of the scheme LoDP & OMU –in farmers' field during the year 2022-23 & 2023-24, in consultation with the District offices of respective districts.
- 10. Preference will be given for designated ODOP coconut districts of Kannur, Kozhikkode & Malappuram, in the selection of project area for the direct implementation of LODP Scheme. However applications from other coconut growing districts also be considered based on the merit of the proposal.
- 11. Weightage will be given to the Farmers Collectives registered with Coconut Development Board.
- 12. CFC will be short listed only based on the merit and scope for the improvement of production, productivity.
- 13. The payment of financial assistance to the beneficiaries shall be under DBT (Direct Benefit Transfer) mode only for the inputs applied under the scheme.
- 14. If in any disputes arise regarding in the scheme implementation, the decision of the Chief executive Officer & Chairman will be final.
- 15. The Chief executive Officer & Chairman have reserve powers to accept or reject any applications fully or partially with or without assigning any reason whatsoever.
- 16. Any disputes arise in the implementation of this project shall be resolved by the court of law of local jurisdiction of Ernakulum only.
- 17. All CDB terms & conditions, amended in time to time will also applicable to this project implementation also.

*Coconut Farmer Clusters (CFC) = Group of coconut farmers from the same vicinity
